After Adèle by Sr. Franca Zonta, FMI

Written to fill the historical gap between Adèle's death and the suppression of Catholic teaching orders in France at the beginning of the twentieth century, Sister Franca develops this history using archival material available in the Archives of the General Administration of the Daughters of Mary. More than half the book details the founding of the Third Order Secular and the Third Order Regular, their relationship to the Daughters of Mary, their apostolates and the eventual merger in 1921 of the Third Order of Auch with the Daughters of Mary. The thinking of Father Chaminade and Mother Adèle concerning the Third Order, the vow of enclosure, the vow of stability, the vow of teaching faith as applied to the Third Order is detailed and explored.

Letters of Adèle de Batz de Trenquelléon (2-Volume Set)

Fr. Joe Stefanelli, SM, says the number of letters from Adèle was "certainly in the thousands. Of them, only 737 have come down to us." Because her companions in service were scattered over a large geographical area, she developed a system of letter writing. She wrote, "It is not so much the style that should preoccupy us, but rather our own improvement." We gain insights into Adèle's personality, her spirituality, her deep faith, her mission, and her desire to live for God alone. Although her life was short—she died when not quite 39—Adèle worked diligently to spread the faith to all around her. The primary work of the Daughters of Mary continued to be the development and guidance of young women of the Sodality and the Association. During her life as a religious, she founded convents at Tonneins, Condom, Agen, Arbois, and Bordeaux.

<u>Living in a Time of Crisis: It's in Our Marianist DNA</u> by Sr. Gabrielle Bibeau, FMI Be it during a time of global pandemic or the French Revolution, Sister Gabrielle Bibeau, FMI, reminds us that biological and societal crises are not new for Marianists. Some of the best chapters are written by women, including Cecilia Araya-Campos, Margaret Cavanaugh, Sr. Anna Huth, Sr. Blanca Jamar, and Carol Quinn (Ramey). While the richness of the work lies in the expansive scope of thought and experience contained in its pages, individuals and groups might find that focusing on a set of papers from a cluster of writers will provide much grist for the reflective mill.

Relations Between the Institute of the Daughters of Mary and the Society of Mary by Sr. Marie Bernard Beaud, FMI

The article explores the troubled relationship between the Daughters of Mary and the Society of Mary, following Blessed Chaminade's death.

<u>A Retreat with Adèle</u> by Sr. Eileen Cehyra, FMI

The booklet is filled with scripture passages centering on Jesus and Mary; the words of Adèle de Batz de Trenquelléon, Foundress of the Marianist Sisters; and reflection questions which can be used for personal or group activities. It is geared toward anyone making a personal retreat or for someone seeking moments of quiet away from the "busyness" of life.

<u>A Sociologist Considers the Contributions of Marie Thérèse de Lamourous</u> by Sr. Laura Leming, FMI

Laura M. Leming, FMI, a sociologist at the University of Dayton and a Marianist Sister, highlights Marie Thérèse's "best practices" of social ministry in relation to this Marianist Founder's work with former sex workers at the Miséricorde.

Stories from the Wake by Mary Lynne Gasaway Hill

Mary Lynne Gasaway Hill, a lay Marianist and professor of English at St. Mary's University, in Stories from the Wake: The Revolutionary Responses of the Sodality of Bordeaux and Small Christian Communities, examines the development of Small Christian Communities (SCCs) related to these two revolutionary moments. She describes shifts in the "grand narrative" of the

day—defined as the foundational sources of meaning that organize and direct people and behavior in a meaningful way—caused by these events. In light of such dramatic changes, where society has become unglued, how does one create a new cohesive bond that draws people into the Christian story? Hill examines the rise of the Small Christian Community movement, both during the time of Father Chaminade and the original Sodality and in terms of today's postmodernism, for possible answers.

Suppression of Religious Orders in France by Sr. Lucia Ubbiali, FMI

This is a fascinating history of what happens when a government promulgates laws promoting anticlericalism. Sister Lucia situates the struggles of the Institute of the Daughters of Mary Immaculate not only in the historical perspective of the French government's repressive attitude towards religious institutes, she also deals with the consequences of these attitudes. Relying on interviews and archival material, Sister Lucia objectively reports the failings and mistakes unavoidable when anyone is forced to grapple with laws and attitudes that threaten an institute's very survival and, by extension, one's own "survival" or way of life. Another interesting part of this history describes the providential merger of the Third Order of Auch, a merger that assured the survival of the Daughters of Mary.

<u>Table Story: The Five Silences and the Olson Circumplex Model</u> by Beth Garascia Beth Garascia, as part of MSP 2.0, shares the importance of "silence of words" and "silence of passions" as they relate to family dynamics. Key to her understanding of Chaminade's Five Silences is her reflection on a special table and the family memories that occurred around it.

Things Marianist: Can You Explain What You Mean When You Say...? by Carol Quinn This issue explains Marianist "jargon" through an imaginary dialogue in a Marianist faith-sharing community. Current members explain to potential new members the definitions and meaning of many of our Marianist terms.

Things Marianist: How Are the Three Offices Like an Orchestra? by Joan McGuinness Wagner and Patti Gehred

It's been said that life is an unforgettable opera: one filled with moments, some positive and some not, that help build character along the way. But perhaps for Marianists a better image is that of an orchestra: different sounds that blend well together to build an outward sense of Christ in and for the world. This *Things Marianist* explores this very concept, and yes it does use orchestral imagery. This easy-to-read, four-page publication not only examines Blessed Chaminade's practical approach to community leadership (the Three Offices) but also provides contemporary language for it—an area some say is needed in Marianist community development today.

Things Marianist: How Can We Be Guided on the Marianist Path? by Bro. Stephen Glodek, SM, Patti Krasensky, and Bro. Tom Redmond, SM

This *Things Marianist* examines Blessed Chaminade's method of prayer both from the perspective of an individual journeying with a companion (spiritual direction) and a communitarian perspective (spiritual accompaniment of a community). Marianist experts Stepehen Glodek, SM; Pati Krasensky; and Thomas Redmond, SM; are the coauthors of this work.

Things Marianist: How Do People Make Commitments to Living Marianist Life? by Alison R. Cawley and Bro. Larry Cada, SM

Hospitable, inviting, prayerful, and thoughtful are words often used to describe the warmth of welcome when one first meets a Marianist. But just what is the source of these qualities . . . that something deeper that inspires the soul and keeps one focused on doing the work of Mary and Jesus day after day, year after year, in good times and in bad? This Things Marianist examines the "keep on keeping on" aspect to Marianist life that is known as stability.

Walking Our Talk Barefooted by Susan Handle Terbay

By examining these events, she hopes to show how being people of hope and faith is part of the DNA of Marianist Sisters, not to mention the Marianist Family as a whole.
